Case Study - Breast Cancer

What would be the best way to try and make something as scary as breast cancer easier to deal with? Our answer is to offer some patients the chance to avoid the trauma of losing a breast and dramatically reducing the need to visit the hospital for post-operative radiotherapy. This breakthrough was achieved in 2010 by sourcing and investing in a fantastic new treatment that not only helps the patient, it saves the NHS money and reduces waiting lists.

Maggie Shaw, 68, had `one-shot' radiotherapy at the Royal Free. The technique involves giving targeted radiotherapy to selected breast cancer patients while in theatre as soon as the cancerous tumour has been removed.



"I was devastated when the doctor at my local hospital said that a mastectomy was the only option. I was very persistent and kept asking whether there was any possibility of saving my breast. Eventually, I was told about a pioneering procedure at the Royal Free which was suitable for certain patients with breast cancer and that I may be eligible.

"The doctor said the technique, called intra-operative radiotherapy, involved giving radiotherapy in one shot during surgery to remove the cancerous lump. It sounded perfect for me as it would mean I could keep my breast and have a significantly less extensive operation.

"During the surgery, Mr Keshtgar also performed a sentinel lymph node biopsy. The results were all clear showing that the cancer had not spread. Now I just have to take a daily tablet for five years to prevent the cancer returning.

"My surgery scar has healed very well and I feel well in myself.

Only a month after surgery, I was back at aqua aerobics and loving it.

"Everyone is terrified when they hear that they have cancer but I was treated incredibly quickly: just three months from diagnosis to having surgery and radiotherapy and getting the all clear."

Leaving your Legacy

Thinking about your own mortality is not at all easy, but it really is all of our responsibility to make sure we write a Will. This protects our legacy and is the only sure way to control what happens to any money or possessions we have when we pass on.

Of course many of us already have a Will, but you might be surprised how many people haven't looked at it yet. Nearly one third of all people never make a Will! Imagine the confusion and possible family problems that lack of foresight can create.

As someone who cares about people, might we suggest that you make a gift to us in your Will. It's easy to do, and you can be comforted by the fact that you are really living on through the wonderful help you will be giving people into the future.

Making a change to an existing Will

If you have already made your Will and would like to add a gift to the Royal Free Charity, you can do this by using a codicil, which is effectively an additional clause. (CAN THIS BE DONE ONLINE?? IF SO ADD IN A WEB ADDRESS) Again, this is a simple legal procedure, and if it's easiest for you, why not chat it through with your solicitor.

What type of **gift** should I leave?

Two main ways that you choose from to leave a gift to the Royal Free Charity in your Will:

- a cash gift: you can choose to give a fixed amount of money
- a percentage of your estate: you can choose to leave a share of what is left in your estate, in total or after you have provided for others.

Leaving a percentage is the option most people prefer, because it means that you won't have to change your Will later if your circumstances change.

Do you have a passion to follow, or have you had experience of treatment you would like to support? We're listening! Here's an example of a lady who did exactly that...

> Case Study - Legacy Art Joan Roberts worked at the Royal Free as a secretary, then later as a senior manager. Joan loved the hospital, and very generously left money in her will for the hospital. One of her real loves in life was art, as she knew how calming and therapeutic it can be to have art around a hospital – it really lightens the mood. She commissioned a sculpture, something special that reflected her positive and happy character. If you are visiting us for any reason, just ask where it is and come and see Joan's legacy for yourself.

Understanding Inheritance Tax

Inheritance Tax is paid if the value of your estate exceeds the threshold set by the government. The threshold is currently \pounds 325,000 which means that Inheritance Tax of 40% is paid on the any of your estate that is valued above this amount. This means that your beneficiaries will keep 60p out of every £1 over the threshold, the other 40p goes to the government.

Many people think that's a lot to send to the taxman! However, here's some good news. A gift to us will not be taxed, and if you do make a gift totalling 10% or more of your estate to us, the remaining estate will only be taxed at 36%, meaning your beneficiaries keep an additional 4p in every \$1 in everything over that tax threshold of \$325,000.

Our commitment to you

As we mentioned earlier, we will do whatever we can to honour any wishes you have as to how the gift you leave us is spent. However, as things do change, if you can be general that helps us... after all, we hope that there will be many years yet before your legacy with us comes into effect!
